

PRI signatories are required to report publicly on their responsible investment activities each year. In turn, they receive a number of outputs, including a public and private Transparency Report.

The private Transparency Reports, which are produced using signatories' reported information, support signatories to have internal discussions about their practices. Signatories can also choose to make these available to clients, beneficiaries, and other stakeholders.

This private Transparency Report is an export of your responses to the PRI Reporting Framework during the 2023 reporting period. It includes all responses (public and private) to core and plus indicators.

Section 1. Our commitment

Why does your organisation engage in responsible investment?

What is your organisation's overall approach to responsible investment, and what major responsible investment commitment(s) have you made?

Environmental, social and governance issues are part of our daily lives and are becoming increasingly prevalent. What seemed somewhat theoretical to companies a decade ago is now very real and affects their business and their value. Managing ESG considerations and integrating them at the core of the business model helps anticipate market trends and identify future-proof companies that create value. This has been Eurazeo's strongly held conviction for nearly 15 years, setting the Group apart as a pioneer with a solid reputation for its ESG performance. As a result, Eurazeo's portfolio is not only resilient but also positioned to benefit from this new economic order.

Throughout the investment cycle, Eurazeo actively contributes to the selection, transformation, and sustainable growth of these companies.

Eurazeo stands out as one of the pioneers among investment groups for its proactive integration of sustainable development into its business since 2008, demonstrating a strong commitment to environmental, social, and governance practices. In 2020, Eurazeo launched its new ESG strategy called O+, structured around two flagship commitments: achieving carbon net neutrality and fostering a more inclusive society so as to contribute to the emergence of a fairer and more sustainable society.

The O+ strategy binds the Group and its portfolio companies, making it a significant driver of transformation.

Contributing to fighting climate change must be a priority for all. Eurazeo is part of a global movement to bring about carbon net neutrality, which the Group seeks to achieve by 2040 at the latest. Eurazeo committed as early as 2020 to defining decarbonization targets in line with the goals set out in the Paris Agreement.

To guarantee the seriousness of this work, the Group use the Science Based Target initiative (SBTi), the world's benchmark methodology. 2022 marks the validation of our decarbonization pathway. Our SBTi commitment binds the Group and the portfolio companies and is aligned with the 1.5°C scenario.

Moreover, the Group continues to develop its sustainable investment strategy via article 8 and 9 dedicated funds (e.g., Eurazeo Transition Infrastructure Fund), contributing, among others, to develop two types of solutions in electric mobility, thermal insulation, circular economy, alternative protein sources, hydrogen, and substitutes for chemical fertilizers as well as digitization, innovation, and R D in the healthcare sector to enhance access, quality of care, and disease prevention.



These solutions amount to €4.3 billion, representing 13% of Eurazeo's total assets under management. These investments are housed in both Eurazeo's ESG thematic funds and across its portfolio.

Eurazeo embraces the principles of the United Nations Sustainable Development Goals (SDGs) as one of its guiding frameworks to advance across all ESG fronts.

Eurazeo's Responsible Investment policy and ESG strategy extend across all asset classes and follow key steps that may be tailored to specific asset classes based on their potential for impactful action:

- Exclusion policy: all potential investments undergo a rigorous evaluation process aligned with the exclusion policy, which incorporates sector and normative exclusions.

- Due Diligence: comprehensive ESG due diligence is conducted to identify and analyse the primary ESG considerations, risks, and opportunities associated with the target investment.

- ESG clauses in legal documentation: these clauses are defined according to the nature of the investments and mainly concern exclusion criteria, annual ESG reporting to assess the deployment, progress and results of ESG programs or measurement of the deployment of a decarbonization strategy.

- Sustainability-linked loans: Eurazeo negotiated the first ESG unitranche for one of its investments.

Backed by 5 ESG criteria, the margin of this financing is reviewed annually depending on the achievement of those objectives. - Engagement program: to assist portfolio companies in integrating ESG into their business models and progressing in their sustainability journey, Eurazeo has developed a customized progress plan adaptable to companies of all sizes and levels of ESG maturity.

- ESG reporting: Eurazeo requires all companies that receive investment from the Group, whether directly or through managed investment funds, to prepare annual ESG reports.

- Control procedures: Eurazeo maintains robust ESG governance and control procedures to ensure the effective implementation of its ESG strategy.

- Divestment phase: In the divestment process, Eurazeo incorporates ESG performance data into datarooms or vendor due diligence processes, allowing potential buyers to assess the ESG performance of the portfolio companies.

- ESG in compensation: Eurazeo strengthens the alignment of interests between its stakeholders by incorporating ESG objectives in up to 15% of the annual varible compensation of its Executive Management.

In early 2023, Sophie Flak became a Managing Partner for ESG and Digital and joined the Executive Board of Eurazeo, reinforcing the company's integration of ESG principles at the highest level. The Board now comprises Mr. Christophe Bavière, President and co-CEO; Mr. William Kadouch-Chassaing, co-CEO; Mr. Olivier Millet, Managing Partner for small-mid Buyout [] NovSanté and Sophie Flak, Managing Partner for ESG and Digital. This appointment marks a significant milestone in Eurazeo's commitment to sustainable and responsible investment and aligns with their ambitious ESG strategy, O+, launched in 2020, focusing on climate action and inclusion.



Progress on several ESG initiatives has been achieved:

1) Public commitments and engagements:

• Eurazeo's Commitment to the Science Based Targets Initiative validated the Group's scope 1 [] 2 targets, aiming to limit global warming below 2°C. They also pledged to reduce scope 3 emissions by 30% by 2030.

• 90% of Eurazeo's active funds are classified under article 8 or article 9, including dedicated funds pursuing sustainable objectives.

• Engagement with various organizations, including the Science-Based Targets Financial sector guidance, supporting 19 non-profit organizations, and signing the gender diversity charter by France Invest.

2) Awards, recognition, and certifications:

• Eurazeo's presence in five non-financial benchmark indices alongside ESG-leading companies.

• Honoured with the 2022 Sustainable Finance Label by L'AGEFI and The France Invest Prize for gender diversity policy.

• Winner of the SWEN Capital Partners Multi-strategy Investment Platform award.

3) Continuous improvement of ESG practices in 2022:

• Launched a program to support portfolio companies in their climate strategies through Connect, an innovative knowledge-sharing platform.

• Conducted biodiversity assessments for all Buyout funds, developing tailored progress plans to enhance biodiversity preservation efforts.

• Maintained a rigorous exclusion policy for 100% of investments.

• Eurazeo demonstrated significant dedication in 2022 to enhance the proportion of article 8 and 9 funds, with an increase from 81% in 2021 to 90%.

Notably, all sustainability indicators of article 9 funds underwent rigorous audits conducted by a certified third-party, further affirming Eurazeo's commitment to transparency and accountability.

• Collaborated with Reclaim Finance about Eurazeo's exclusion policy on the coal, and oil and gas, with the objective of enhancing transparency and adopting standardized vocabulary. The goal of this process was to improve the clarity and transparency of the language in the existing exclusion policy. The Group maintains its conviction to exclude the financing of activities related to coal, oil and gas.

· Conducted thorough ESG Due Diligence for every investment to address sustainability risks and opportunities.

• Launched a health benefits policy engagement campaign among US portfolio companies to ensure equal access to health services for all employees in a Roe vs Wade context.

• Over the last ten years, ESG programs have generated savings of around €263 million to the Group's investments.

They also enabled reductions of 1.5 million metric tons of CO2 equivalent in emissions, nearly 12 million cubic meters in water, more than 3,100 GWh in energy and nearly 480,000 hours of absence.

• Finally, Eurazeo has reinforced its ESG team by hiring two full time employees.

Sophie Flak's appointment and these initiatives exemplify Eurazeo's dedication to sustainable and responsible investment, emphasizing their commitment to generating positive social and environmental impact while delivering sustainable financial returns.

Section 3. Next steps

What specific steps has your organisation outlined to advance your commitment to responsible investment in the next two years?



In line with the O+ strategy, Eurazeo aims to advance its commitment over the next two years through the following steps, within the framework of the final targets set for 2030:

• Increase of the share of responsible investment products across all its investment branches. This includes offering investment products that adhere to Article 8 and Article 9 of the European Union's Sustainable Finance Disclosure Regulation (SFDR). End of June 2023, those investments represents 4.7 b€, approx.13% of Group AUM.

• Increase of the share of investments eligible to the EU Taxonomy (In 2022, 41% of investments in Article 8 funds, and 75% of investments in Article 9 funds are eligible).

• Deployment of its net carbon neutrality trajectory according to the Science-Based Targets Initiative (SBTi) at management and portfolio level and the additional objective of reducing scope 3 emissions in absolute terms by 30% by 2030.

• Eurazeo also aims to achieve five main targets pertaining to inclusion by 2030. These targets include reducing gender inequality, increasing the representation of the underrepresented gender at the board level and in executive teams, attaining a Gender Diversity Index score of 85/100, and achieving an adjusted gender pay gap of 13%.

• Implement a dedicated roadmap for 100% of assets with high biodiversity challenges by 2030 according to the Convention on Biological Diversity principles.



ESG is also represented on the Executive Board by Sophie Flak, Managing Partner ESG and Digital, who was appointed to the Executive Board in early 2023. Her main duties in regard to ESG involve defining and deploying Eurazeo's ESG strategy, developing new sustainable investment products, engaging with stakeholders overseeing the ESG team and be accountable for all ESG commitments and policies.

Eurazeo has set up a dedicated ESG team in 2008, currently composed of six full-time members. Its main role is to ensure the proper implementation of the ESG strategy within the Group and its investments.

Eurazeo has implemented different levels of controls and internal audit to ensure compliance and risk mitigation:

• Supervisory Board: which is responsible for the global strategic decisions and ensures risk mitigation and compliance at group level.

• Audit committee: which refers also directly to the Supervisory Board. One of its missions is to ensure the effectiveness of compliance systems.

This committee also decides of the measures to be implemented to promote compliance and to reduce risks such as: regulation benchmark, internal control systems, insurance policies and members' governance.

• Compliance officer: each of Eurazeo's subsidiaries has its own compliance officer. They are in charge of (i) supervising permanent control (realized by employees on a daily basis) and (ii) realizing compliance, internal procedures and risk controls. Eurazeo delegates compliance functions to third parties to ensure independence.

• Eurazeo employees: they manage to operate permanent control (level one) on a daily basis and are supervised by the compliance officer.
